Release, Hold Harmless, Indemnification and Defense Agreement

1. RECITAL OF FACTS RE: RISKS

A. I / We, the undersigned hereby acknowledge, recognize and agree with Hollywood Hill Equestrian Center, Inc., that all horses and ponies of any age, regardless of training, care and control, are unpredictable animals whose major psychological traits and size make them potentially dangerous to themselves, their handlers and riders, and to other horses and to other persons in the vicinity of a horse and / or pony. Therefore, there is always a serious risk of accidents, injuries, harm and damages to the horses and / or ponies, their handlers, their riders and to other horses and / or ponies and to other persons in the vicinity of a horse and / or pony.

B. I / We, the undersigned hereby acknowledge, recognize and agree with Hollywood Hill Equestrian Center, Inc., that the undersigned has voluntarily entered into this Release, Hold Harmless, Indemnification and Defense Agreement as an inducement to Hollywood Hill Equestrian Center, Inc., to permit the undersigned to have access to and use the premises, facilities, horses, tack, and related property and premises of Hollywood Hill Equestrian Center, Inc., for the enjoyment of engaging in and / or observing horseback riding, training and grooming and caring for the horses owned by, or used by the lessor, or leased by a non-owner; the undersigned acknowledges, recognizes and agrees that permission for use of Hollywood Hill Equestrian Center, Inc., and services supplied by Hollywood Hill Equestrian Center, Inc., are directly preconditioned upon the acceptance and signing of this Release, Hold Harmless, Indemnification and Defense Agreement.

2. ACCEPTANCE OF RULES FOR USE OF PREMISES AND FACILITIES
